PREFATORY STATEMENT

Under the Plantilla of Personnel and Staffing Pattern of the local government unit of Siayan, Zamboanga del Norte, there are Three (3) nurse positions in the Municipal Health Office (MHO) namely: Nurse 1, SG/Step - 10/1, Nurse II, SG/Step - 15/6 and Nurse III, SG/Step - 18/2.

Whereas, Nurse III position above-mentioned was erroneously created under Municipal Ordinance No. 03-003, dated March 7, 2003 based on the Qualification Standard of the Civil Service Commission (CSC) that Nurse III is only Salary Grade 17 and not Salary Grade (SG) - 18.

The Department of Budget and Management (DBM) Budget Circular No. 2021-2, dated August 25, 2021 subject of such is "MODIFICATTION OF NURSE POSITION" wherein the purpose as stated is to prescribed the rules and regulations on the upgrading of the previous Nurse positions.

In compliance of the DBM directives hence this enactment.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

"MUNICIPAL ORDINANCE NO. 22-02

Series of 2022

\$ECTION I. TITLE. This shall be known as "AN ORDINANCE MODIFYING/UPGRADING THE SALARY GRADE OF NURSES POSITION IN THE PLANTILLA OF PERSONNEL AND STAFFING PATTERN OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE THE SAME TIME AMENDING THE SALARY GRADE OF NURSE III POSITION UNDER MUNICIPAL ORDINANCE NO. 03-003, DATED MARCH 7, 2003.

\$ECTION II. MODIFICATION IN THE POSITION ATTRIBUTES OF NURSE POSITIONS: Pursuant to DBM Budget Circular No. 2021-2 the position attributes of the following classes of Nurse positions are hereby modified/upgraded effective January 1, 2022.


