**PREFATORY STATEMENT**

Municipal Ordinance No. 20-25, Series of 2020 known as the "Municipal Comprehensive Children's Code" was acted on December 7, 2020, consequently submitted to the Hon. Sangguniang Panlalawigan for review, unfortunately, it was returned without favourable action under SP Resolution No. 286, dated May 25, 2022 with advice as stated:

"Article XVIII, Section 143 of Municipal Ordinance No. 20-25 be amended insofar as the penalty imposed for violation of any provisions thereof has exceeded the penalty prescribed under Section 447, paragraph (a) sub paragraph (i) (iii) of RA 7160 known as the Local Government Code of 1991"

The review action of the Hon. Sangguniang Panlalawigan had lapsed for almost One (1) year and Eight (8) months wherein as provided under Section 56, paragraph (d) stated: "if no action has been taken by the Sangguniang Panlalawigan within Thirty (30) days after submissions of such ordinance or resolution, the same shall be presumed consistent with law and therefore valid.

In view thereof, Municipal Ordinance No. 20-25, series of 2020 is hereby presumed consistent with law and therefore valid however as amended hence this enactment.

**BE IT ORDAINED** by the Sangguniang Bayan in session assembled:

**"MUNICIPAL ORDINANCE NO. 22-06**

Series of 2022

**SECTION I. TITLE.** This Ordinance shall be known as, **"AN ORDINANCE AMENDING ARTICLE XVIII, SECTION 143 OF MUNICIPAL ORDINANCE NO. 20-25, SERIES OF 2020.**

**SECTION II. AMENDMENTS.** The penal provisions of Municipal Ordinance No. 20-25, series of 2020 is hereby amended as follows:

"ARTICLE XVIII, SECTION 143 OF (MUNICIPAL ORDINANCE NO. 20-25)". PENAL PROVISION. Any violation hereof, upon conviction by the proper court shall be penalized an imprisonment of not exceeding Six (6) months and/or a fine ranging from One Thousand (Php1,000.00) pesos to Two Thousand (Php2,500.00) pesos."

**SECTION III. REPEALING CLAUSE.** That Article XVIII, Section 143 of Municipal Ordinance No. 20-25 is hereby repealed and modified accordingly.


**SECTION IV. EFFECTIVITY.** This Ordinance shall take effect upon approval.
