PREFATORY STATEMENT

Whereas, the municipality of Siayan, Zamboanga del Norte is a recipient of Farm to Market Road (FMR) project from the Department of Agriculture (DA) under the Philippine Rural Development Program (PRDP) particularly concreting of barangay Gonayen – Barangay Balunokan Farm to Market Road;

Whereas, such assistance is under contract wherein the recipient Local Government Unit is required to provide a counterpart fund for its implementation, hence this enactment.

"APPROPRIATION ORDINANCE NO. 01

Series of 2023

SECTION I. TITLE. This shall be known as "AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF EIGHT MILLION FIVE HUNDRED FIFTYFIVE THOUSAND, SEVEN HUNDRED THIRTYONE PESOS AND EIGHTYTWO CENTAVOS (PHP8,555,731.82) SOURCED FROM THE 20% CONTINUING APPROPRIATION CY 2022 AS COUNTERPART FUND FOR PROP PROJECT CONCRETING OF GONA/ON-BALUNOKAN FARM TO MARKET ROAD (FMR).

SECTION II. AVAILABILITY OF FUNDS. That the amount of **PHP8,555,731.82** sourced from the 20% continuing appropriation CY 2022 is hereby made available.

SECTION III. EFFECTIVITY. That this ordinance shall take effect upon approval.
