PREFATORY STATEMENT

Whereas, the municipality of Siayan, Zamboanga del Norte is a recipient of Farm to Market Road (FMR) project from the Department of Agriculture (DA) under the Philippine Rural Development Program (PRDP) particularly concreting of barangay Gonayen - Barangay Balunokan Farm to Market Road;

Whereas, such assistance is under contract wherein the recipient Local Government Unit is required to provide a counterpart fund for its implementation, hence this enactment.

"APPROPRIATION ORDINANCE NO. 01
Series of 2023

SECTION I. TITLE. This shall be known as **"AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF EIGHT MILLION FIVE HUNDRED FIFTYFIVE THOUSAND, SEVEN HUNDRED THIRTYONE PESOS AND EIGHTYTWO CENTAVOS (PHP8,555,731.82) SOURCED FROM THE 20% CONTINUING APPROPRIATION CY 2022 AS COUNTERPART FUND FOR PRDP PROJECT CONCRETING OF GONAYEN-BALUNOKAN FARM TO MARKET ROAD (FMR).**

SECTION II. AVAILABILITY OF FUNDS. That the amount of **PHP8,555,731.82** sourced from the 20% continuing appropriation CY 2022 is hereby made available.

SECTION III. EFFECTIVITY. That this ordinance shall take effect upon approval.
