PREFATORY STATEMENT

The Municipal Treasurer and Municipal Accountant had certified the availability of funds amounting to THIRTY SIX MILLION FOUR HUNDRED SEVENTY EIGHT THOUSAND FOUR HUNDRED EIGHTEEN PESOS AND FIFTY SIX CENTAVOS (PHP36,478,418.56) sourced from Retained Earnings available for operation and subject for budgeting to cater the various expenditures of the local government unit of this municipality.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

"APPROPRIATION ORDINANCE NO. 23-02

Series of 2023

SECTION I. TITLE. This shall be known as "AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF THIRTYSIX MILLION FOUR HUNDRED SEVENTYEIGHT THOUSAND FOUR HUNDRED EIGHTEEN PESOS AND FIFTYSIX CENTAVOS (PHP36,478,418.56) REPRESENTS RETAINED EARNINGS AVAILABLE FOR OPERATION EMBODIED IN SUPPLEMENTAL BUDGET NO. 1 FY 2023 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. AUTHORITY AND AVAILABILITY OF FUNDS. That the amount of THIRTYSIX MILLION FOUR HUNDRED SEVENTYEIGHT THOUSAND FOUR HUNDRED EIGHTEEN PESOS AND FIFTYSIX CENTAVOS (PHP36,478,418.56) is hereby made available and authorized for various expenditures of the local government unit.

SECTION III. OBJECT OF EXPENDITURES. That the Supplemental Budget shall be appropriated of the different projects, programs and activities of the local government unit. Statement of Funding Sources (LBP Form No. 8) and Statement of Supplemental Appropriation (LBP Form No.9) are hereto attached as form part of this ordinance.

SECTION IVI. EFFECTIVITY. That this ordinance shall take effect upon approval.
