**PREFATORY STATEMENT**

WHEREAS, the local government unit of this municipality had collected revenues source from the rentals of heavy equipment amounting to **THREE MILLION TWO HUNDRED SIXTY ONE THOUSAND FOUR HUNDRED FOUR PESOS (PHP3,261,404.00)** available for operation and subject for budgeting to cater for the purchase of One (1) Unit concrete mixer truck of the local government unit of this municipality.

**BE IT ORDAINED** by the Sangguniang Bayan in session assembled:

**"APPROPRIATION ORDINANCE NO. 23-05**

Series of 2023

**SECTION I. TITLE.** This shall be known as "**AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF THREE MILLION TWO HUNDRED SIXTY ONE THOUSAND FOUR HUNDRED FOUR PESOS (PHP3,261,404.00) REPRESENTS RETAINED EARNINGS AVAILABLE FOR OPERATION EMBODIED IN SUPPLEMENTAL BUDGET NO. 2 FY 2023 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE**".


**SECTION II. AUTHORITY AND AVAILABILITY OF FUNDS.** That the amount of **THREE MILLION TWO HUNDRED SIXTY ONE THOUSAND FOUR HUNDRED FOUR PESOS (PHP3,261,404.00)** is hereby made available and authorized for various expenditures of the local government unit.

**SECTION III. OBJECT OF EXPENDITURES.** That the Supplemental Budget shall be appropriated to purchase of One (1) Unit Concrete mixer truck of the local government unit. Statement of Funding Sources (LBP Form No. 8) and Statement of Supplemental Appropriation (LBP Form No.9) are hereto attached as form part of this ordinance.


**SECTION III. EFFECTIVITY.** That this ordinance shall take effect upon approval.
