**PREFATORY STATEMENT**

**WHEREAS**, at present, there are a considerable number of Barangay Health Workers (BHW) and Barangay Nutrition Scholar (BNS) deployed and serving the twenty-two (22) barangays of the municipality;

**WHEREAS**, Barangay Health Workers (BHW) and Barangay Nutrition Scholar (BNS) are the indispensable partners of the Local Government Unit in the promotion of basic rural health programs and activities, and attending to children's basic needs, childcare workers organize activities and implement curricula that stimulate children's physical, emotional, intellectual, and social growth;

**WHEREAS**, considering the magnitude and risk of the services in their respective localities, it is essential for the municipal government to look into their status and augment their living conditions especially during this time of hardship.

**WHEREAS**, it is but fitting and proper that barangay health workers be duly recognized and given at least a token compensation for their selfless sacrifices and dedicated service in serving their respective localities hence this enactment.

**AN ORDINANCE GRANTING AMELIORATION ALLOWANCE TO BARANGAY HEALTH  
WORKERS AND BARANGAY NUTRITION SCHOLAR IN THE MUNICIPALITY OF SIAYAN,  
PROVINCE OF ZAMBOANGA DEL NORTE.**



**SECTION 1. TITLE.** This Ordinance shall be known as "An Ordinance Granting Amelioration Allowance to Barangay Health Workers (BHW) and Barangay Nutrition Scholar (BNS) of the Municipality of Siayan, Province of Zamboanga Del Norte".

**SECTION 2. DEFINITION OF TERMS.** As used in this Ordinance, the following words and phrases shall be defined as follows:

- A. Barangay Health Workers – refers to as person who has undergone training programs under any accredited government and non-government organization and who voluntarily renders primary health care services in the community after having been accredited to function as such by the local health board in the accordance with the guidelines promulgated by the Department of Health (DOH).
- B. Primary Health Care Approach – recognized as the major strategy towards health empowerment, emphasizing the need to provide accessible and acceptable health services through the participatory strategies such as health education, training of barangay health workers, community building and organizing.

**SECTION 3. OBJECTIVE.** The Local Government Unit of Siayan aims to augment the meager resources being received by the barangay health workers and Nutrition Scholars for the whole Municipality.

**SECTION 4. BENEFIT.** A barangay health worker and Barangay Nutrition Scholar in every barangay of this municipality shall receive an allowance of One Thousand Pesos (Php 1,000.00) every end of the year in recognition of their valuable services to their respective barangays.

**SECTION 5. APPROPRIATION OF FUNDS.** The Local Government Unit of Siayan shall appropriate funds therefore which shall be used for the above-purpose. Funds for the implementation of this Ordinance in every succeeding year shall be provided for in the annual budget of each particular year.


**SECTION 6. REPEALING CLAUSE.** All local ordinances, resolutions and executive orders, or part or parts thereof which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 7. SEPARABILITY CLAUSE.** If, for any reason or reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.


**SECTION 8. EFFECTIVITY.** This Ordinance shall take effect upon its approval.

**ENACTED** this 15<sup>th</sup> day of May 2023.


