"MUNICIPAL ORDINANCE NO. 05-14
Series of 2005

PREFATORY STATEMENT

The Local Government Unit through this august body had acted an Ordinance No. 05-08 effecting the demolition of the old market building located in-between Benlot and Adaza Street, consequently initiated the construction of new market buildings for its replacement however, due to limited funds its demolition-construction was made staggered by Phase.

Presently, the LGU had provided funds of the said project for the continuation/construction of phase II, hence this ordinance to effect the demolition of the remaining portion of the said old market building.

BE IT ORDAINED by the Hon. Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE EFFECTING THE DEMOLITION OF THE REMAINING PORTION OF THE OLD MARKET BUILDING, LOCATED IN-BETWEEN BENLOT AND ADAZA STREET AT MUNICIPAL PUBLIC MARKET LIKEWISE CONTRUCTION OF NEW MARKET BUILDING PHASE II FOR ITS REPLACEMENT".

SECTION II. ORDAINING CLAUSE. That the remaining portion of the old market building located at municipal public market, stand in-between Benlot and Adaza Street shall be demolished consequently the construction of new market building Phase II.


