PREFATORY STATEMENT

The Municipal Engineering Office Staffing Pattern only composed of a Municipal Engineer, a Draftsman and a Construction Foreman as technical personnel, where master of concentration is on the vertical projects, however lack of personnel especially in horizontal projects particularly on the preparation of plans and specifications of roads and others engineering related works

In like manner Computer Operator IV has been included as one of the required positions in the LGU's Information Systems Strategic Plan (ISSP) which is now a mandate for every LGU under the e-LGU Computerization Program which indispensable in the planning office.

On the other hand due to the implementation of the New Government Accounting Systems (NGAS) additional regular personnel is necessary to handle and maintain subsidiary ledgers, index cards, remittances and other financial reports, in such financial records of 22 barangays also maintain by the Accounting Office, likewise in the performance of Local Legislative-related functions as may assigned by the Sanggunian or individual members to the Secretariat hence in need of additional personnel.

This Ordinance is creating different positions due to the exigency of its services however funding appropriation is subject to availability of funds and in conformance on the budgetary limitations of personal services as provided under Sec. 325 of RA 7160.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE CREATING THE POSITIONS OF ENGINEERING AIDE-SG-4, SURVEYING AIDE-SG-4, THREE (3) ADMINISTRATIVE AIDE-SG-4, CLERK I-SG-4, COMPUTER OPERATOR IV-SG-14, ADMINISTRATIVE ASSISTANT IV-SG-10, ADMINISTRATIVE ASSISTANT III-SG-9, ADMINISTRATIVE ASSISTANT II-SG-8, ADMINISTRATIVE AIDE III-SG-3, AND LEGISLATIVE STAFF OFFICER I-SG-14 AND THE SAME SHALL BE INCORPORATED IN THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN AND INCLUSION IN THE PLANTILLA OF PERSONNEL OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE.

SECTION II. ORDAINING CLAUSE. Due to the exigency of the services, different positions are hereby created in the following offices:
