"MUNICIPAL ORDINANCE NO. 05-09
Series of 2005

PREFATORY STATEMENT

RA 9211, known as the Tobacco Regulation Act of 2003 was finally ratified by the congress on June 23, 2003, and one of the concerns provided therein is to regulate the use of cigarettes and tobaccos.

The primary purpose and the main thrust of this act is to promote a healthful environment, inform the public of the health risks associated with cigarette smoking, tobacco use, and among others. (Sec. 3 of RA 9211)

To promote healthful environment as provided in Section 5 of said act, smoking shall be absolutely prohibited in public places, like schools, offices, bus terminal, public market, public conveyance and etc.

For humanitarian reasons and to protect the rights of the persons who are addicted smokers, and in conformance with the provision of RA 9211, smoking area within the municipal hall complex and within the public market premises shall be designated hence this ordinance.

BET IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE DESIGNATING SMOKING AREA WITHIN THE MUNICIPAL HALL COMPLEX AND PUBLIC MARKET PREMISES AT POBLACION IN CONFORMANCE WITH SECTION 6 OF RA 9211 KNOWN AS THE TOBACCO REGULATION ACT OF 2003".

SECTION II. DESIGNATED SMOKING AND NON-SMOKING AREAS. The following areas are hereby designated as the smoking area and all other places within the municipal hall complex and within the public market premises except the herein identified as smoking areas are considered as non-smoking area. Attached herewith is a sketch map of Municipal Streets reflected therein the designated area numbered 1 to 3 which is form part of this ordinance.

1. On the vicinity of the left corner upon entering the Municipal Hall Complex.
2. On the vicinity of the corner intersecting Adaza Street and Aguinaldo Street.
3. On the vicinity fronting the Slaughterhouse along A.B. Siasico St. Street.

SECTION III. ADMINISTRATIVE PROVISION. The Local Government Unit through the Municipal Engineering Office shall cause the posting of at least one (1) legible and visible sign in every designated area and not designated area namely "SMOKING AREA" and "NON-SMOKING AREA" or "NO SMOKING".

The same office shall establish benches/chairs and put-up a cigarette butts depository.

SECTION IV. PENALTY CLAUSE: Any person smoking outside of the designated smoking area within the Municipal Hall Complex and within the market premises is a violation of this ordinance and shall be apprehended and be penalized based on the following offense:

1 st Offense.....	P 500.00
2 nd Offense.....	800.00
3 rd Offense.....	1,000.00 and an imprisonment at the discretion of the Honorable Court.

SECTION V. SEPARABILITY CLAUSE. Any violations related to the use of tobacco products not provided in this ordinance, the provisions of RA 9211 shall be applied.

SECTION VI. MISCELLANEOUS PROVISIONS. The fine collected from any violator shall be paid to the Municipal Treasurer, likewise said personnel or her/his duly authorized representative shall issue the corresponding official receipt and the funds shall be accounted as penalty of Ordinance No. 05-09.

SECTION VII. EFFECTIVITY. This Ordinance shall take effect 60 days after approval of the Sangguniang Panlalawigan and posting of copies at conspicuous places and publication of official gazette.

**"MUNICIPAL ORDINANCE NO. 05-10
Series of 2005**

PREFATORY STATEMENT

Municipal Ordinance No. 99-07 known as the Rabies Prevention Control Ordinance is mandating the owners to register/license their pet dog aging from 3 months old and prior to its registration/licensing the dog shall undergo rabies vaccination administered by the Municipal Rabies Control Authority.

The expenses of vaccines and other medicines needed in vaccination of dogs shall be borne by the Local Government Unit. Other than the vaccination cost, the Municipal Rabies Control Authority will provide dog tag as sign of vaccinated and registered/licensed dogs which is additional expense of the LGU.

Unfortunately, Section VI of Municipal Ordinance No. 99-07 was imposing a dog registration/licensing fees and/or charges in the amount of P20.00 per head, which is minimal compared to the expenses incur of vaccination requirements.

In fairness with the owners and the Local Government Unit, the imposition of fees and or charges reflected under Section VI of Ordinance No. 99-07 shall be amended, hence this ordinance.

BE IT ORDAINED by the Sangguniang Bayan in session assembled.

SECTION I. TITLE. This Ordinance shall be known as "AN ORDINANCE IMPOSING FEES AND/OR CHARGES IN THE REGISTRATION/LICENSING OF DOG IN THE AMOUNT OF P100.00 PER HEAD AMENDING SECTION VI OF MUNICIPAL ORDINANCE NO. 99-07 KNOWN AS THE RABIES PREVENTION AND CONTROL ORDINANCE"

SECTION II. ORDAINING CLAUSE. There shall be collected fees and/or charges in every registration/licensing of dogs in the amount of P100.00 per head

SECTION III. MISCELLANEOUS PROVISIONS. This Ordinance is form part of the Municipal Revenue Code of Sayan, Zamboanga del Norte.

SECTION IV. REPEALING CLAUSE. The fees and/or charges in the amount of Twenty (P20.00) under Section VI of Municipal Ordinance No. 99-07 is hereby repealed and modified accordingly.

SECTION V. EFFECTIVITY. This ordinance shall take effect upon approval of the Hon. Sangguniang Panlalawigan of Zamboanga del Norte.

**"MUNICIPAL ORDINANCE NO. 05-11
Series of 2005**

PREFATORY STATEMENT

The government Procurement Reform Act (RA 9184) and its implementing rules and regulations explicitly provides that each procuring entity shall established Bids and Awards Committee to undertake the functions specified in Sec. 13 of the IRR-A.

The law also provides that the procuring entity may grant payment of honoraria to the BAC members, secretariat, and technical working group not to exceed 25% of the respective basic monthly salary, the guidelines of which shall be promulgated by the Department of Budget and Management.

In like instance, the Department of Budget and Management has promulgated that the honoraria shall be only sourced out from the sale of bidding documents which standard forms are provided by the Government Procurement Policy Board.

Considering the jury duty requirement of law for all the members and work force of the BAC, it is but appropriate to rate the forms at reasonable prices to generate funds for the payment of their honoraria.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE FIXING THE RATE OF THE PHILIPPINE BIDDING DOCUMENTS (PBD's) STANDARD FORMS FOR SALE TO INTERESTED BIDDERS WHO INTEND TO JOIN PROCUREMENT CONTRATS WITH THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. ORDAINING CLAUSE. The rate of the set of bidding documents on the procurement of goods and civil works for sale to interested bidders on the basis of the Approved Budget of the Contract (ABC) is hereby fix based on the following bracket:

50,000.00 and below	- 150.00
above 50,000.00 to 250,000.00	- 250.00
above 250,000.00 to 500,000.00	- 500.00
above 500,000.00 to 750,000.00	- 750.00
above 750,000.00 to 1million	-1,000.00
above 1 million	-2,000.00

SECTION III. ADMINISTRATIVE PROVISION. The funds generated from the sales of bidding forms and other documents shall be the only funds to be utilized for the honoraria of the Bids and Awards Committee (BAC) members.


SECTION IV. EFFECTIVITY. This Ordinance shall take effect upon approval of the Honorable Sangguniang Pantalarawan of Zamboanga del Norte, posting of copies at conspicuous places and publication in the official gazette.


Since there being no further business before the Honorable Sangguniang Bayan in session assembled this the Chair declared session adjourned at 5:00 O'clock in the afternoon.


