



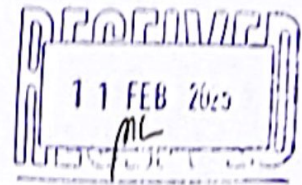

NOW, THEREFORE, Due to deliberation and on motion of Barangay Kagawad Edward P. Ambatal duly second by all barangay council, it was.


