# MEMORANDUM OF AGREEMENT FOR DOCTORS TO THE BARRIOS PROGRAM

KNOW ALL MEN BY THESE PRESENT:

This AGREEMENT is entered into by and among:

The DEPARTMENT OF HEALTH (DOH), a government agency created and existing under the laws of the Republic of the Philippines, with principal office located at San Lazaro Compound Sta. Cruz, Manila herein represented by JOSHUA G. BRILLANTES, MD, MPH, CESE, in his capacity as the OIC-Director of Zamboanga Peninsula - Center for Health Development, and herein referred to as the DOH;

AND

The Municipality of Siayan, Zamboanga del Norte, Philippines, likewise a government agency created and existing under the laws of the Philippines, herein represented by its Mayor, ATTY. JOSECOR S. GEPOLONGCA, and with office address located at Siayan, Zamboanga del Norte, herein referred to as the Local Government Unit (LGU);

AND

DR. PATRISHA F. QUEMA with residence at Sangandaan, Quezon City assigned in the municipality of Siayan, Zamboanga del Norte as part of the DOH-Doctors to the Barrios Program, herein referred to as the DTTB.

WITNESSETH

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991, states that the functions and responsibilities for the delivery of basic health services and other related facilities have been transferred from the DOH to the LGU;

WHEREAS, the LGU, considered as one of the municipalities in the Philippines by the DOH with critical gap of population to physicians, is in dire need of the Rural Health Physician (RHP) under the Doctors to the Barrios (DTTB) Program who will address its health problems;

WHEREAS, the DOH, pursuant to its mandate of providing adequate health human resource in all doctorless municipalities especially in hard-to-reach areas, is recommending to provide a much-needed Doctor to the Barrio (DTTB) by the name of DR. PATRISHA F. QUEMA, and the LGU is willing to accept the same;

WHEREAS, the purpose of the DTTB is to provide health care to areas without a physician;

NOW THEREFORE, in consideration of the foregoing premises, by mutual consent, the parties do hereby enter into and agree to the following terms and conditions:

- a. The services of Dr. Patrisha F. Quema in the municipality of Siayan, Zamboanga del Norte shall be a period of Ten (10) months and Fifteen (15) days from March 15, 2022 to January 6, 2023.
- b. The DTTB (Dr. Patrisha F. Quema) shall provide health care services and develop local health systems/programs/projects based on the priority need of the locality under the Doctors to the Barrio Program (DTTB).
- c. The LGU of Siayan, Zamboanga del Norte shall grant honorarium including the board and lodging in the amount of THIRTYFIVE THOUSAND (Php 35,000.00) pesos.
