



WHEREAS, the BLGU of Mangilay presently relies on the stocks of Sangguniang Barangay when there is a need for chairs;



RESOLVED FURTHER, that copies of the resolution be forwarded to the HON. SB MEMBER RAUL P. DOMINISE for his information and appropriate action


