RESOLUTION HUMBLY REQUESTING HONORABLE SENATOR IMEE R. MARCOS, FUNDING ASSISTANCE AMOUNTING TO THREE HUNDRED THIRTY FIVE MILLION (PHP335,000,000.00) PESOS FOR THE CONSTRUCTION OF CONCRETE BRIDGE AT BARANGAY DIONGAN RIVER CONNECTING BARANGAY DATAGAN AND DIONGAN BOUND TO BARANGAY GUIBO OF THIS MUNICIPALITY.

WHEREAS, the municipality of Siayan, Zamboanga del Norte was known to be the poorest municipality throughout the Philippines, hence the local officials formulated various plans and programs to uplift and stabilize the economic status of the people;

WHEREAS, one (1) of the programs is to develop potential tourist attractions and destinations and one of these is the "GUIBO WATERFALLS" located at Barangay Guibo of this municipality, however prior to reach in this area, it will pass through DIONGAN RIVER, which is not passable of any four-wheeled vehicles;

WHEREAS, a concrete bridge is deemed necessary to improve connectivity, safety, and economic activities in the area;

WHEREAS, considering that the LGU has only limited funds, thus the municipality needs funding assistance from the National Government particularly from the generous Honorable Senator Imee R. Marcos for the realization of the above-mentioned projects;

WHEREFORE, premised considered and on motion of on Hon. Roel J. Pabiran, unanimously seconded, it was

RESOLVED, as this body hereby resolved by HUMBLY REQUESTING HONORABLE SENATOR IMEE R.
