**RESOLUTION CALLING A GROUP OF VOLUNTARY INDIVIDUALS FOR EMERGENCY
RESPONSE IN THE MUNICIPALITY OF SIAYAN ZAMBOANGA DEL NORTE.**

WHEREAS, the Municipality shall promote the health and safety of its inhabitants, and maintain peace and order within its jurisdiction;

WHEREAS, the municipality is responsible for the coordination and delivery of basic, regular and direct services and effective governance of the inhabitants within its territorial jurisdiction;

WHEREAS, the maintenance of peace and order, prevention and suppression of lawlessness, disorder, riot, violence, rebellion or sedition are essential to the general welfare of the inhabitants;

WHEREAS, the local government unit and other agencies concerned could not warrant appropriate and immediate response without the help and/or assistance from the citizens hence this sentiments calling any individuals or groups to act voluntarily the following response:

- a. Assist the pertinent local and national first responder agencies/offices in responding the natural emergencies, such as, but not limited to typhoon, earthquake, landslide, flood, or any other natural calamity;
- b. Assist the pertinent local and national first responder agencies/offices in responding to man-made emergencies, such as, but not limited to terrorism, armed violence, disorder, riot, lawless violence, rebellion or sedition;
- c. Coordinate with the various government agencies and offices for the Municipal emergency response to either natural or man-made emergencies;
- d. Report suspicious persons or instances of illegal activities, which might lead to man-made emergencies, such as, but not limited to terrorism, armed violence, disorder, riot, lawless violence, rebellion or sedition.
