MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS

This Memorandum of Agreement executed by and between:

DEPED SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE, government office under the Department of Education (DepEd) with the Principal office at Siayan, represented herein by the Schools Division Superintendent, **VIRGILIO P. BATAN JR. CESO VI** herein referred to as "DepEd"

-and-

MUNICIPALITY OF SIAYAN, Local Government Unit (LGU) created under the Philippine laws, with the principal office at Siayan, represented herein by **MAYOR JOSECOR S. GEPOLONGCA**, herein after referred to as "LGU"

-WITNESSETH-

WHEREAS, the DepEd Division of **Zamboanga del Norte**, is in need of additional day care center, particularly within the catchment area of the Municipality of **Siayan**, to accommodate 20 pupils;

WHEREAS, the establishment of the proposed **BULANAO DAY CARE CENTER** is considered an urgent need in the Municipality of Siayan as indicated in the project feasibility.

WHEREAS, the municipality of **Siayan** agrees to be a counterpart of DepEd in the establishment of the proposed building;

NOW THEREFORE, for and in consideration of the terms and conditions hereinafter set forth, the parties hereby agree to the following provisions:

2.2 Continue to provide financial assistance through the Special Education Fund.

3. OTHER CONDITIONS OF THE MOA

3.1 This MOA does not in any way prevent the parties from entering into other stipulations as may hereafter be to by the said parties ; and

3.2 No part or portion of the MOA shall be amended or modified without the written approval of the parties hereto

4. FINAL PROVISIONS

This MOA shall be the sole governing document of the relationship between DepEd and LGU with reference to establishment of Bulanao Day Care Center.

5. EFFECTIVITY OF THE MOA

This MOA shall be valid upon signing by both parties and shall effective for the period of from the date of signing , or until such time that sufficient funding is provided for in the General Appropriations Act in favor of BULANAO ELEMENTARY SCHOOL.
