### "RESOLUTION NO. 066

RESOLUTION ADOPTING SEVERAL LAWS, AND ISSUANCES FROM THE NATIONAL GOVERNMENT, SUCH AS REPUBLIC ACTS, DOH ADMINISTRATIVE/MEMORANDUM ORDERS, AND NATIONAL NUTRITION COUNCIL (NNC) GOVERNING BOARD RESOLUTIONS FOR IMPLEMENTATIONS IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE.

WHEREAS, in consistent with the local autonomy and decentralization as provided under Rule V, Article 24, of the Rules and Regulations implementing the RA 7160 known as the Local Government Code of 1991, delivery of basic services and facilities shall be devolved from the National Government to provinces, municipalities and barangays so that each LGU shall be responsible for minimum set of services and facilities in accordance with established policies, guidelines and standards;

**WHEREAS,** several laws (Republic Act) had been ratified, Memorandum Circulars and Administrative Orders has been issued from the concerned agencies as part of policies and guidelines for adoption and implementation of the local government unit;
