### RESOLUTION SETTING-UP A REFERRAL SYSTEM FOR ACUTE MALNUTRITION IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE.

**WHEREAS**, child acute malnutrition can be identified in primary health centers and in the communities before the onset of complications.

**WHEREAS,** detecting and referring children with acute malnutrition are the foundation for integrated management of malnutrition at facility and community level, however there must be a referral system protocol to be followed;

**WHEREAS**, the Health and Nutrition Referral System of this municipality shall be the following set-up:

1<sup>st</sup>.from the Community:

Coordination from Barangay Nutrition Scholar (BNSO or Barangay Health Worker

(BHW) to Grassroots Livelihood Development Coordinator (GLDC)/Assigned NDPP or Midwife on any health and Nutrition problems/concerns

2<sup>nd</sup> the Barangay:

From GLDC/assigned NDP and Midwife, will do assessment and referral slip prior to Coordination to Rural Heal Unit/Facility.

3<sup>rd</sup> the MHO, PHN and MNAO

MHO will re-validate the health and nutrition concerns and for malnutrition cases it will refer to MNAO to Midwife and Nurses and give appropriate management and for further management will be refer to District Hospital/Provincial Hospital.

**WHEREFORE**, premise of the foregoing consideration and on motion of Hon. Emelyn P. Tulawe, duly seconded by Hon. Estrella S. Zapatos, it was

RESOLVED, as this body hereby resolved by SETTING-UP A REFERRAL SYSTEM FOR ACUTE MALNUTRITION IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE.
