**RESOLUTION AUTHORIZING THE OIC MUNICIPAL TREASURER MR. RAIMER H. MELINDO TO TRANSFER THE AMOUNT OF TWO MILLION SEVEN HUNDRED SIXTY FIVE THOUSAND SIX HUNDRED PESOS (PHP2,765,600.00) FROM GENERAL FUND TO TRUST FUND REGULAR AS COUNTERPART FUND FOR THE HONORARIUMS OF CDT, DCW, BHW AND BNS CY 2022.**
