## "RESOLUTION NO. 126 Series of 2025

RESOLUTION ADOPTING REPUBLIC ACT NO. 11291, OTHERWISE KNOWN AS THE "MAGNA CARTA FOR THE POOR".

**WHEREAS**, the 1987 Constitution of the Republic of the Philippines mandates the State to promote social justice in all phases of national development and to provide for a system of protection and assistance for the underprivileged;

WHEREAS, Republic Act No. 11291, or the "Magna Carta for the Poor" was signed into law on April 12, 2019, to ensure the full enjoyment of the basic rights of the poor, including the right to adequate food, decent work, relevant education, adequate health services, and safe and decent housing;

WHEREAS, Section 3 of R.A. No. 11291 defines the "poor" an individuals or families whose income falls below the poverty threshold, as defined by the Philippine Statistics Authority (PSA), and who cannot afford their minimum basic needs;

**WHEREAS**, the law directs all government agencies and instrumentalities to prioritize the needs of the poor in the formulation and implementation of their programs and services;

**WHEREAS**, it is the commitment of the Local Government Unit of Siayan to support national policies promoting poverty alleviation and inclusive development;

**WHEREFORE**, premised considered and on motion of Hon. Daisy A. Limbang, duly seconded by Hon. Dave F. Labadlabad, it was

**RESOLVED**, as it is hereby resolved, that the Local Government Unit of Siayan formally adopts and supports Republic Act No. 11291, the Magna Carta for the Poor.
