**"RESOLUTION NO. 127
Series of 2025**

RESOLUTION ADOPTING REPUBLIC ACT NO. 11930, OTHERWISE KNOWN AS THE "ANTI-ONLINE SEXUAL ABUSE FOR EXPLOITATION OF CHILDREN (OSAEC) AND ANTI-CHILD SEXUAL ABUSE OR EXPLOITATION MATERIALS(CSAEM) ACT".

WHEREAS, the 1987 Constitution of the Republic of the Philippines declares that the State shall defend the right of children to assistance, including proper care and special protection from all forms of neglect, abuse, cruelty, exploitation, and other conditions prejudicial to their development;

WHEREAS, Republic Act No. 11930, also known as the "Anti-OSAEC and Anti-CSAEM Act", was enacted to strengthen measures for the protection of children against all forms of online sexual abuse and exploitation, and to hold accountable all perpetrators and enablers of such heinous crimes;

WHEREAS, the prevalence of technology-facilitated child abuse including livestreamed exploitation and distribution of exploitative content, poses an immediate threat to the welfare, dignity, and safety of children in our communities;

WHEREAS, this body recognizes the urgency of localizing and implementing the provisions of R.A. No. 11930 through education, policy enforcement, coordination with law enforcement and collaboration with community stakeholders;

WHEREFORE, premise considered and on motion of Hon. Daisy A. Limbang, duly seconded by Hon. Wencito B. Intoy, it was

RESOLVED, as this body hereby resolved that this august body hereby adopts Republic Act No. 11930 in full support of its objectives and mandates.

RESOLVED FINALLY, to furnish copies of this resolution to all offices concerned for information and appropriate action.
