**"RESOLUTION NO. 128
Series of 2025**

RESOLUTION ADOPTING REPUBLIC ACT NO. 11036, OTHERWISE KNOWN AS THE "MENTAL HEALTH ACT", TO PROMOTE MENTAL HEALTH AWARENESS, PROTECTION, AND SUPPORT WITHIN THE LOCAL GOVERNMENT UNIT OF SIYAN, ZAMBOANGA DEL NORTE.

WHEREAS, the 1987 Philippine Constitution upholds the right of every Filipino to health, including mental health, as part of their fundamental human rights;

WHEREAS, Republic Act No. 11036, or the "Mental Health Act", was enacted to establish a national mental health policy directed toward improving the mental health care system, promoting the mental health care system, promoting mental well-being, and protecting the rights of Persons with Mental Health Conditions (PMHCs);

WHEREAS, mental health issues continue to rise, particularly among the youth and vulnerable populations, requiring an urgent and inclusive response from all sectors of society;

WHEREAS, the Local Government Unit of Siyan, Zamboanga del Norte recognizes the need to adopt and localize R.A. No. 11036 to foster a supportive environment that enhances mental health awareness, provides accessible services, and eliminates stigma and discrimination;

NOW THEREFORE, on motion of Hon. Daisy A. Limbang, duly seconded by Hon. Dave F. Labadlabad, it was

RESOLVED, as this body hereby resolved that this august body formally adopts Republic Act No. 11036, the "Mental Health Act", as a guiding framework for all policies, programs, and initiatives related to mental health promotions and support.
