**WHEREAS**, Republic Act No. 11650, also known as the "Instituting a Policy of Inclusion and Services for Learners with Disabilities in Support of Inclusive Education Act", was enacted to ensure that learners with disabilities have access to quality education and support services in an inclusive learning environment;

**WHEREAS**, the Local Government Unit of Siayan recognizes the importance of inclusive education and is committed to promote the rights and welfare of learners with disabilities;


