**"RESOLUTION NO. 132**

RESOLUTION ADOPTING REPUBLIC ACT NO. 11596, OTHERWISE KNOWN AS THE "ACT PROHIBITING THE PRACTICE OF CHILD MARRIAGE AND IMPOSING PENALTIES FOR VIOLATIONS THEREOF", AND EXPRESSING FULL SUPPORT FOR ITS IMPLEMENTATION IN THE LOCAL GOVERNMENT UNIT OF SIYAN, ZAMBOANGA DEL NORTE.

**WHEREAS**, Republic Act No. 11596 was enacted to protect the children for the harmful practice of child marriage, which undermines their rights and well-being;

**WHEREAS**, the law defines child marriage as any marriage entered into where one or both parties are children, including solemnized marriages and informal unions of cohabitations outside wedlock between an adult and child, or between children;

**WHEREAS**, the law imposes penalties on individuals who cause, facilitate, or officiate child marriages, as well as on adults who cohabit with children outside wedlock;

**WHEREAS**, the Department of Social Welfare and Development (DSWD) is tasked in leading the implementation of this law, including the creation of programs to address the prevalence of child marriage and provide appropriate services to victims;


**WHEREFORE**, premise considered and motion of Hon. Daisy A. Limbang, duly seconded by Hon. Dave F. Labadlabad, it was


