RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), THROUGH THE NATIONAL ECONOMIC DEVELOPMENT AUTHORITY (NEDA) TO PRIORITIZE THE CONSTRUCTION OF A CONCRETE BRIDGE AT BARANGAY DIONGAN, SIAYAN, ZAMBOANGA DEL NORTE TO ADDRESS ACCESSIBILITY AND SOCIO-ECONOMIC HARDSHIPS IN THE AREA.

**WHEREAS**, the Municipality of Siayan is one of the most geographically isolated and economically disadvantaged municipalities in the Province of Zamboanga del Norte, with a significant portion of its population living in poverty and relying heavily on agriculture and manual labor for livelihood, thereby declared as No. 1 poorest municipality in Region IX;

**WHEREAS**, the residents of Barangay Diongan and adjacent communities are severely affected by the absence of a permanent and reliable bridge, which hampers transportation, access to education, health services and the delivery of government assistance, especially during rainy seasons;

**WHEREAS**, the proposed construction of a concrete bridge at Diongan River of Barangay Diongan will provide a safe, year-round passable for people, goods and emergency services, thereby enhancing mobility, safety and local economic development;

**WHEREAS**, it is the duty of the local government unit to advocate for the needs of its constituents and to call upon the national agencies and funding institutions to assist in uplifting the welfare of the poorest communities, thus respectfully and urgently requesting the **Department of Public Works and Highways (DPWH) through the National Economic Development Authority (NEDA)** funding assistance amounting to **One Hundred Million Pesos (PHP100,000,000.00)** for the Construction of Concrete Bridge at Diongan River of Barangay Diongan, Siayan, Zamboanga del Norte;


