RESOLUTION REQUESTING THE LOCAL GOVERNMENT UNIT (LGU) OF THIS MUNICIPALITY THROUGH THE HON. MUNICIPAL MAYOR ALBERTO J. BONGCAWEL TO UNDERTAKE THE CUTTING AND PRUNNING OF OLD TREES WITHIN THE PREMISES OF THE SIAYAN OFFICIALS AND EMPLOYEES MULTI-PURPOSE COOPERATIVE (SOEMPUCO) BUILDING.

WHEREAS, the SOEMPUCO building is in danger and vulnerable to be destroyed due to the existence of old mahogany planted trees owned by the Local Government that might wipe out in the occurrence of tropical storm with heavy rains and strong winds and directly fall to the cooperative building;

WHEREAS, any individual person or group of persons could not easily facilitate its cutting and pruning with their own skills considering that the aforementioned trees are big and too high that needs prescribed equipment to perform particularly backhoe or crane for its safety;

WHEREAS, the SOEMPUCO could hardly compel to contract with the services of the private construction company to its cutting/pruning due to non-availability of funds;
