WHEREAS, the Local Government Unit of Siayan, Zamboanga del Norte had maintained Trust Fund Account No. 2552-1090-18 for ARCP2 Operation and Maintenance, however it occurred dormancy due to non-activity of such account considering that ARCP2 has no projects at all in this municipality;
