A RESOLUTION INDORSING TO THE CONCERN GOVERNMENT AGENCIES FOR INCLUSION IN THE BARANGAY DEVELOPMENT PLAN IN SUPPORT TO THE NATIONAL TASK FORCE FOR THE ELIMINATION OF LOCAL COMMUNIST ARMED CONFLICT (INTF- ELCAC) THE PROJECT PROPOSAL OF OUR BARANGAY TO REQUEST FROM THE OFFICE OFF NATIONAL COMMISSION ON INDIGENUOS PEOPLES (ITF) ELCAC CHAIRMAN ALLEN CAPUYAN OF THE FUNDING IN THE AMOUNT OF FOUR MILLION PESOS (PHP 4,000,000.00) FOR THE PURCHASE AND INSTALLATION OF SOLAR STREET LIGHTS AT THE BARANGAY PANGE, SIAYAN ZAMBOANGA DEL NORTE.
