## **CONTRACT OF AFFILIATION**

**KNOW ALL MEN BY THESE PRESENTS:**

**This CONTRACT OF AFFILIATION, made and entered this \_\_\_\_\_ day

**THE LOCAL GOVERNMENT UNIT OF SIAYAN ZAMBOANGA  
DEL NORTE, herein represented in this Act by HON. ALBERTO  
BONGCAWEL, Municipal Mayor, hereinafter referred to as the FIRST  
PARTY;**

**PHILIPPINE ADVENT COLLEGE, an institution of higher  
learning with SEC Registration no. 112801 duly organized and  
existing under the laws of the Republic of the Philippines, duly  
authorized and recognized by the Department of Education,  
Commission on Higher Education and TESDA to offer Basic  
Education Curriculum, Collegiate and Technical-Vocational Courses,  
with principal office at Ramon Magsaysay, Sindangan, Zamboanga  
del Norte herein represented by PIO M. CERNAL, College President,  
hereinafter referred as the SECOND PARTY**

**WITNESSETH:**

**WHEREAS, the FIRST PARTY has maintained and operated a Birthing  
Home and Rural Health Units existing and operating legally under the laws  
of the Philippines;**

**WHEREAS, the SECOND PARTY, wants to affiliate in the Department  
of Health Hospitals and other government health facilities for the training  
of their Bachelor of Science in Nursing, and Midwifery students.**

**WHEREAS, by virtue of Section 35 & 36 of Republic Act No. 7160, the local government units may link and assist with people's and governmental organization....to engage the delivery of basic services.... To enhance the economic and social well being of the people, and with occurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organization for economic, socially oriented.... projects to be implemented within its territorial jurisdiction;**

**WHEREAS, pursuant to DOH Administrative Order No. 5-A, series of 1996 particularly Section 2 thereof, in part, states that, "The production and development of Health Human Resources are necessary for the promotion, maintenance and delivery of health services. The Department of Health is making available its hospitals and accredited government, community health resources for the learning and training of students from health professional schools".**

#### **TERMS AND CONDITIONS**

**1. The FIRST PARTY agrees and allows the use of Siayan Diagnostic Center and other Rural Health Units of the Municipality , as an institution, for the affiliation and training of the following students , namely;**

**a. Bachelor of Science in Nursing**

**b. Two- Year Midwifery**

**2. That the FIRST PARTY shall not be held liable for any injury or damages suffered by the SECOND PARTY's trainee-students arising from accident, force majeure and/or fortuitous event during the existence of this contract;**

**3. That the SECOND PARTY shall be liable to the FIRST PARTY for any damages that may be caused by the trainee-students to the latter's properties;**

**4. The SECOND PARTY binds itself to comply with the policies in the Rural Health Units as regards patient care, proper decorum and behavior,**

**cleanliness and sanitation, among others, as embodied in various memoranda and issuances of the Honorable Mayor and the Municipal Administrator;**

**5. The SECOND PARTY commits to submit to the merit-demerit system of evaluating the school's compliance with the terms and conditions of the contract, in particular, in evaluating performance, behavior and attitude of its student nurses, the outcome of which shall be one of the factors to be considered in the renewal of the contract;**

**6. The duration of affiliation will be:**

**a. Bachelor of Science in Nursing – 80 to 120 hours per group or until they have completed the required number of Deliveries handled, Assisted Labor and Newborn Care.**

**b. Midwifery – 120 to 360 hours per group or until they have completed the required number of Deliveries Handled, Assisted Labor and Newborn Care.**
