BADDIRI, REGIONAL OFFICE 9, CABATANGAN, ZAMBOANGA CITY FOR THE INSTALLATION/CONSTRUCTION OF CELLULAR SITE TOWER IN THE DIFFERENT BARANGAYS WITH NO TELECOMMUNICATION SIGNAL IN THE MUNICIPALITY OF SIYAN, ZAMBOANGA DEL NORTE.

WHEREAS, the telecommunication plays an important role in the country, through wireless communications, however it could not be materialized if the respective areas nationwide could not access signals therefore installation of cell sites boosts the reception or signal which will undoubtedly improve the network signal in the far-flung barangays and non-signal barangays needing reliable telecommunications signal for the general welfare of the people in this municipality;

WHEREAS, the National Telecommunications Commission (NTC) has the integrity in facilitating signal reception of cellular phone and other wireless communications devices like cellphones, telephone, televisions, radio and other gadgets in a cellular network;

WHEREAS, the following barangays are no signal: Gunyan, Gonayen, Datagan, Sayaw, Macasing, Balunokan, Dingan, Guibo, Seriac, Mangilay, Soguilon, Domogok, Dumpilas and Balok;
