RESOLUTION REQUESTING THE MUNICIPAL MAYOR ALBERTO J. BONGCAWEL, THRU THE HONORABLE MUNICIPAL VICE MAYOR ATTY. JOSECOR S. GEPOLONGCA AND ALL HONORABLE SANGGUNIANG BAYAN MEMBERS OF SIAYAN, ZN FOR FINANCIAL ASSISTANCE FOR THE CONSTRUCTION / INSTALLATION OF POTABLE WATER SUPPLY SYSTEM, LEVEL II OF BARANGAY PANGE, SIAYAN, ZAMBOANGA DEL NORTE.

WHEREAS, Barangay Pange is one of the 22 barangays of Siayan that can be considered as waterless in terms of potable or drinking water supply, due to the fact that at present majority of the households of barangay Pange has no access to potable water system, level 2 for common household tap stands/faucets, since the water supply that is available is only the water system, level 1, thus, majority of its inhabitants or majority of the populace in the barangay resort to fetching water that is not safe for drinking that can be pinpointed as one of the causes of stomach aches and/or diarrhea to some of the residents; especially to sitio Sinatalan;

WHEREAS, one of the priorities of the Local Government Unit of Barangay Pange is that a potable water system in level 2 category shall be established/constructed or installed in the barangay to minimize water-borne illnesses that aggravates poverty conditions among its residents; and adds to the problem of financial hardships that is still prevalent among the majority of the populace, especially in this times of COVID 19 pandemic situation;

WHEREAS, as per record, the Barangay Treasury has only meager or insufficient funds that is not enough to implement the long-envisioned potable water supply, level 2 project for all the household residents, hence, there is a need to seek for external sources of funds to realize the construction, installation of potable water supply system, level 2 in the barangay;

NOW, THEREFORE, on motion of Barangay Kagawad Ailyn Antubo, duly seconded by all Barangay Kagawad members, it was

RESOLVED, as it is hereby resolved, to request the Municipal Mayor Hon. Alberto J. Bongcawel, thru the Municipal Vice Mayor Hon. Atty. Josecor S. Gepolongca and all members of the Sangguniang Bayan of Siayan for financial assistance for the construction, installation of potable water supply system, level 2 in the barangay;
