WHEREAS, the municipality of Siyan was once declared as the poorest municipality throughout the country, wherein despite of the powers implied to the local officials for efficient and effective governance for the general welfare of the constituents but still this municipality belongs to the poverty line as a poor municipality due to limited funding sources;

WHEREAS, one contributory factor to be considered for the improvements of our people and to boost the economic conditions of this municipality is the existence of all weathered farm to market roads from the remotest barangays bound to the central market;

WHEREAS, good roads are nothing when it will traverse big rivers, most likely all roads in this town always across a river hence necessitates the construction of bridges particularly as follows:

1. Barangay Poblacion connecting Barangay Paranglumba
2. Barangay Datagan connecting Barangay Diongan
3. Barangay Datagan connecting Barangay Macasing
