RESOLUTION REQUESTING THE HONORABLE CONGRESSWOMAN GLONA LABADLABAD FOR FINANCIAL ASSISTANCE FOR THE CONSTRUCTION AND CONCRETING OF MACASING-PANGE FARM-TO-MARKET ROAD (FMR).

WHEREAS, the existing Farm-to-Market Road (FMR) of Barangay Pange can still be classified as a dirt road inspite of the fact that every year the said access road to barangay Pange is maintained by gravelling, however, during rainy days, the applied sand and gravel are washed out of the road carried by the strong current of surface water due to heavy rains that last for eight (8) hours, usually this happens during the months of May, June, and other succeeding months especially during stormy weather;

WHEREAS, dirt roads in areas whose terrain is characterized from rolling to hilly are prone to strong runoff surface water that cause scouring and canal developments crisscrossing the dirt and graveled dependent roads that makes transport vehicles hard to navigate and makes travel dangerous;

WHEREAS, in communities with such types of roads, agricultural development and progress is slow, and the future of the majority of its inhabitants will remain in uncertainty; hence the barangay officials who are well-acquainted with the hardships of living in far flung areas of barangays decided to find means in realizing their long-dreamed farm-to-market road project;

WHEREAS, due to meager funds, the Sangguniang Barangay decided to seek funds from outside sources, and to set aside a counterpart for the implementation of the project;

NOW, THEREFORE, on motion of Barangay Kagawad Manuel EboI, duly seconded by Barangay Kagawad Dalmacio A. Lubac, it was

RESOLVED, as it is hereby resolved, to request from the Honorable Congresswoman Glona Labadlabad, Representative of the Second Congressional District of Zamboanga del Norte for financial assistance for the construction and concreting of Macasing-Pange Farm-to-Market Road (FMR);
