PREFATORY STATEMENT

WHEREAS, under Section 391 of the local Government Code of 1991, (R.A. 7160) to wit: The Sangguniang Barangay, the legislative body of the Barangay, shall be composed of the Barangay Captain as the Presiding officer, the regular sangguniang Barangay Members, the President of the Pambayang Pederasyon ng mga Sangguniang kabataan, and the Sectoral Representative, as members;

WHEREAS, the Sangguniang Barangay has evolved and emerged to be a dynamic body that focuses not just in local legislation but also in the meaningful exercise of local autonomy and effective and efficient delivery of basic services;

WHEREAS, adopting an official seal for the office of the Sangguniang Barangay serves the purpose of having a concrete symbol of its authority as well as constant reminder of the duties and responsibilities of its official and employees as defined under the Barangay Code, other laws, rules and regulations affecting Barangay and Public services;

BE IT ORDAINED by the Sangguniang Barangay in session assembled:

SECTION I. TITLE. This shall be known as **"AN ORDINANCE ADOPTING THE OFFICIAL SEAL OF THE SANGGUNIANG BARANGAY OF POLAYO, SIAYAN, ZAMBOANGA DEL NORTE, REGULATING ITS USE AND PROVIDING PENALTY FOR VIOLATIONS THEREOF"**.

SECTION II. PURPOSE. Adopting an official seal for the office of the Sangguniang Barangay serves the purpose of having a concrete symbol of its authority as well as constant reminder of the duties and responsibilities of its official and employees as defined under the Barangay Code, other laws, rules and regulations affecting Barangay and Public services;

SECTION III. DESCRIPTION OF IMAGE (SEAL). The Official Seal of the Sangguniang Barangay of Polayo shows the image inside the circle.

1. THE CARABAO

The carabao is the main draft animal of the farmers of Barangay Polayo. It is farmer's only means of ensuring a bigger cultivation during land preparation for the production of rice, corn, rubber, coconut, and other secondary crops or intercrops.

2. THE PLOW, THE YOKE AND THE ROPE THAT CONNECTS THE PLOW

The plow that is pulled by the carabao thru the yoke and the rope and other accessories attached to the plow helps in making the work in land preparation, particularly during the first plowing and second plowing easier and lighter for the farmers to accomplish their job.

3. THE FARMER

The farmer represents the entire residents of Barangay Polayo of their daily tasks and effort of ensuring high production and sustainable food supply for their families, and the place in the Community

The picture of the carabao pulling the plow and administered or managed by the farmer symbolizes the cooperation and unity of the people residing or living in the Barangay to attain strong socio-economic development together with the Barangay officials.

4. SEVEN STARS

The Seven Golden Stars represent the seven sitios of Barangay Polayo, one of the members Sangguniang Barangay headed by the Barangay Captain who work together for the realization of the goal to have a proactive legislative body. The seven sitios of the Barangay they serve as the guiding stars that will light the path towards the attainment and realization.

5. THE RICE CORN RUBBER AND COCONUT

The rice corn rubber and coconut represent the barangay Polayo, Zamboanga del norte, as the number one and first official livelihood of the people. It serve as the mostly needed in every individual and in every families.

6. THE GAVEL

The Gavel is extremely important and necessary in the exercise of the legislative power of the Barangay. It symbolizes the authority and right to act officially in the capacity of a chair or presiding officer. It is use for commanding attention or confirming an action to keep the session or meeting itself became and orderly and the closing or adjournment of proceeding, meeting or session. The Gavel reminds every member of the Barangay of their duties and responsibilities as legislators.

SECTION IV. USE OF THE SAGGUNANG BARANGAY SEAL. Only the official of the Sangguniang Barangay and its local officials and employees shall use the corporate seal:

- a. To authenticate all Barangay documents and other administrative issuances.
- b. As letterhead in official communication or correspondent in the exercise of the Sangguniang Barangay legislative and other functions.
- c. To be affixed upon such other official document, plates and papers of the office of the Sangguniang Barangay of Polayo as may be provided by a Barangay resolution or ordinance, or as may be required by custom or usage
- d. As a symble of the Barangay in all its affairs, with or outside of its territorial jurisdiction.
- e. To be affixed upon Barangay pins, service, rings, stickers or be embroided and affixed upon the uniforms of Barangay officials and Employees.

SECTION V. CUSTODY OF THE ORIGINALLY LAY-OUT OF THE SEAL

The office of the Sangguniang Barangay Secretary shall have the custody of the of the official seal of the Sangguniang Barangay of Polayo, Scanned and saved in a computer or in a disc.

SECTION VI. PROHIBITED ACTS.

- a. To mutilate, deface, defile, trample on, or cast contempt by any act or omission casting dishonor or ridicule upon the official seal;

- b. To display the seal under any frame or picture;
- c. To display the seal in a platform or stage during programs not hosted by the Barangay of Polayo;
- d. To add any word, figure, mark, picture, design, advertisements, or any nature on the seal;
- e. To print, paint or attach representation of the seal on handkerchief, napkins, and other articles of merchandise except upon authority of the Sanggunang Barangay.

SECTION VII. PENAL CLAUSE

- 1. Any person, group of persons, Barangay officials or Employees who violates any provision of this ordinance shall be subject to reprimand, discipline, suspension or any administrative liability depending on the gravity of the offense, without prejudice to the filing of appropriate civil or criminal action;
- 2. Any person affixing the dry seal on any document without the knowledge and consent of the Barangay Captain or the Barangay Secretary, or destroying the dry seal shall be meted a fine of Five Hundred Pesos (500.00) or imprisonment or Barangay service of eight (8) hours or both fine imprisonment or Barangay service at the discretion of the court; without prejudice to the filing of the appropriate civil or criminal action. Provided however, that persons who destroy the dry seal aside from the penalty shall immediately replace the destroyed dry seal.


SECTION VIII. EFFECTIVITY CLAUSE


This ordinance shall take effect after complying the requirement as to posting and publication as for under Section 59 of RA 7160.




