**RESOLUTION EXPRESSING INTENT TO REQUEST A PHYSICIAN TO BE ASSIGNED IN THE
MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE UNDER THE DOCTORS TO THE
BARRIO (DTTB) PROGRAM OF THE DEPARTMENT OF HEALTH (DOH).**

WHEREAS, in pursuant to the devolution of Human Resource for Health (HRH) under the National Health Workforce Support System (NHWSS) of the Department of Health (DOH), Physicians shall be deployed to the priority areas particularly the fifth (5th) and sixth (6th) class municipalities;

WHEREAS, the municipality of Siayan, ZN was declared as a third (3rd) class municipality, however considered as Geographically Isolated and Disadvantaged Areas (GIDA) considering that more or less 70% cultural minority (Subanen) in population, and the same time there are eight (8) barangays are under End Local Communist Armed Conflict (ELCAC);

WHEREAS, the contract of the Doctors to the Barrio (DTTB) presently assigned in this municipality in the person of Dr. Patrisha Quema is nearly end and will be terminated;

WHEREAS, the Local Government Unit is willing to provide the funding requirements for the board and lodging and other emoluments for the Doctor to be deployed in this municipality;

WHEREFORE, premised of the foregoing consideration, and on motion of Hon. Raul P. Dominise, duly unanimously seconded, it was


