

3 MONTHS BUT LESS THAN 4 MONTHS	Not exceeding Php 4,0000
2 MONTHS BUT LESS THAN 3 MONTHS	Not exceeding Php 3,0000
Less than 2 months	Not exceeding Php 2,0000


