RESOLUTION ESTABLISHING AND ADOPTING THE CULTURAL INVENTORY OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE, AND ENDORSING THE SAME TO THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) FOR INFORMATION AND GUIDANCE.

WHEREAS, Section 14, 15, 16 and 17, Article XIV of the 1987 Constitution declare that the State shall foster the preservation, enrichment and dynamic evolution of a Filipino Culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression. The Constitution likewise mandate the State to conserve, develop, promote, and popularize the nation's historical and cultural heritage and resources, as well as artistic creations. It further provides that all the country's artistic and historic wealth constitutes the cultural treasure of the nation and shall be under the protection of the State, which may regulate its disposition;

WHEREAS, Section 2 of republic Act No. 10066, otherwise known as the "national Culture of heritage Act of 2009", mandates the protection, preservation, conservation and promotion of the nation's cultural heritage, its property histories, and the ethnicity of local communities. Section 14 (b) and (c) of the same Act, requires local government units to establish and maintain a Local Cultural Property Registry;

WHEREAS, Joint Memorandum Circular No. 2021-001 issued by the Department of the Interior and Local Government – National Commission for Culture and the Arts (DILG-NCCA) specified the amended guidelines on the standardized submission of Local Culture Inventory which requires the LGUs to cause the submission of their updated Local Culture Inventory and its required attachments to the agency which shall form part of the Philippine Registry Cultural Property (PRECUP);

WHEREAS, in compliance thereto, this august body hereby adopt the Cultural Inventory of the Local Government Unit of Siayan, Zamboanga del Norte, and strongly recommends such for inclusion in the PRECUP;

WHEREFORE, premised considered and on motion of Hon. Billynel C. Catig, unanimously seconded, it was

RESOLVED, as this body hereby resolved by ESTABLISHING AND ADOPTING THE CULTURAL INVENTORY OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE, AND ENDORSING THE SAME TO THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) FOR INFORMATION AND GUIDANCE.
