TO ALL CLIENTS ARE GIVEN FREE OF CHARGE ON THE THIRD MONDAY OF FEBRUARY, 1994 AND YEAR  
THEREAFTER, A HIGHLIGHTS OF THESE CIVIL REGISTRATION TOWARDS YEAR 2000.

WHEREAS, main thrust of the National government is to hasten birth registration,  
so that in the year 2000, none registered persons are thoroughly eliminated.

WHEREAS, to achieve such goal comfortably the Local Government Unit with its  
Legislative Body may pass a measures extending incentives to registrants once a  
year;

NOW THEREFORE, after due deliberation and on motion of SB Member Apolinario L.  
Entrina, Sr. duly seconded by SB Member Samuel G. Baculpo, Sr. it was


RESOLVED, as this <sup>body</sup> hereby resolved, to declare that business transaction with

Carried unanimously.


