RESOLUTION REQUESTING THE LOCAL CHIEF EXECUTIVE HON. MAYOR ALBERTO JUMALON BONGCAWEL THRU THE HONORABLE BODY OF SANGGUNIANG BAYAN OF SIAYAN, ZAMBOANGA DEL NORTE FOR THE ANNUAL APPROPRIATION OF FUNDS IN THE AMOUNT OF ONE HUNDRED EIGHTY THOUSAND PESOS (PhP180.000.00) FOR THE HONORARIUMS OF THE OFFICERS AND BOARD OF DIRECTORS OF THE MUNICIPAL FEDERATION OF SENIOR CITIZENS ASSOCIATION OF THE PHILIPPINES (MFSCAP) SIAYAN CHAPTER TO SUPPORT THEM ON THEIR MONTHLY BARANGAY VISITATION ACTIVITIES OF MONITORING FOR THE PURPOSE OF ENABLING AND CAPACITATING THE OFFICERS OF THE TWENTY-TWO (22) BARANGAY SENIOR

CITIZENS ASSOCIATION OF THE PHILIPPINES (BSCAP) OF SIAYAN, ZAMBOANGA DEL NORTE, CHARGEABLE AGAINST THE 1% SHARE FROM THE INTERNAL REVENUE ALLOTMENT (IRA) OTHERWISE KNOWN AS NATIONAL TAX ALLOTMENT (NTA)/LOCAL FUNDS FOR CY- 2025.

WHEREAS, the Officers and Board of Directors of the Municipal Federation of Senior Citizens Association of the Philippines (MFSCAP), Siayan Chapter is conducting enabling and capacitating activities for the Barangay Senior Citizens Association of the Philippines (BSCAP) of the 22 barangays of Siayan, Zamboanga del Norte;

WHEREAS, the initiative of conducting the above-mentioned activities is to help empower the (BSCAP) officers of the 22 barangays of the municipality by sharing and/ or conveying to them vital information relative to their rights and privileges in claiming and utilizing their ONE PERCENT (1%) SHARE from the National Tax Allotment (NTA)/ Local funds that shall be received by their respective Barangay Government Unit or BLGU in consonance with Republic Act 9994, the General Appropriations Act of 2003, Memorandum Circulars from the Department of Budget and Management (DBM), and for them to know the consequence that may be imposed upon Officials or any person or corporation who shall violate any provision of RA 9994 as per **Article 24 of the Implementing Rules and Regulations of RA 9994**, viz;

Article 24. PENALTIES – Any person who refuses to honor the senior citizen card or violates any provision of the act Act and its Rules shall suffer the following penalties:

Section 1. For the first violation, a fine of not less than Fifty thousand pesos (Php 50,000.00) but not exceeding One hundred thousand pesos (Php 100,000.00) and imprisonment for less than two (2) years but not more than (six) years; and

Section 2. For any subsequent violation, a fine of not less than One hundred thousand pesos (Php 100,000.00) but not exceeding Two hundred thousand pesos (Php 200,000.00) and imprisonment for not less than two (2) years but not more than six (60) years.

Section 3. Any person who abuses the privileges granted herein shall be punished with a fine of not less than Fifty thousand pesos (50,000.00) but not more than One hundred thousand pesos (100,000.00) and imprisonment of less than six (6) months.

Section 4. If the offender is an alien or a foreigner, he/she shall be deported immediately after service of sentence without further deportation proceedings.

Section 5. if the offender is a corporation, partnership, Organization or any similar entity the officials thereof directly involved such as the president, general, manager, managing partner, or such other officer charged with the management of the business affairs shall be liable thereof.

Section 6. Upon filing of an appropriate complaint, and after due notice and hearing, the proper authorities may also cause the cancellation or revocation of the business permit, permit to operate, franchise and other similar privileges granted to any person, establishment or business entity that fails to abide by the provisions of the Act and these Rules.

WHEREAS, as per report by the BSCAP officers of some barangays in a meeting with the Federation or MFSCAP Officers, there are still BSCAP Officers who were not able to utilize their 1% share from the IRA of which it is now known as the National Tax Allotment (NTA)/Local Funds due to some reasons and of their innocence of RA 9994 and IRR;

WHEREAS, the BSCAP officers in the 22 barangays have some other issues and concerns that need to be resolved or cleared with the presence of the MFSCAP Board of Directors and Officers of the MFSCAP or Federation of Senior Citizens Association of Siayan, Zamboanga del Norte; and those of the Barangay Officials;

WHEREAS, such activity, considering its monthly scope of schedule to cover all 22 barangays, do need financial support from the LGU of Siayan, Zamboanga del Norte for the smooth implementation of its plans/programs/project/ and or activities (PPAs), and other contingencies to benefit the Senior Citizens, and encourage them to actively join the Barangay Senior Citizens Association in their respective barangay, and to give them clear understanding on the benefits of joining and supporting the mortuary aid program of the MFSCAP of Siayan Chapter.

WHEREAS, the Board of Director Mrs. Rosita Digamon presented idea of resolving issues and concerns; and after a few minutes of thorough discussion the Board of Directors and Officers of MFSCAP, Siayan Chapter, agreed to pass a resolution to appropriate funds for the honorariums of the Officers and Board of Directors of MFSCAP, Siayan Chapter in consideration of its tasks and responsibilities to the BSCAP of the 22 barangays of Siayan, Zamboanga del Norte chargeable against the 1% share from the IRA or the National Tax Allotment (NTA)/Local funds of CY-2025.

NOW THEREFORE, premise considered, on motion of MFSCAP BOD Mrs. Digamon and BOD member Franklin Ambatal duly seconded by all member and rest of the members of the Board present, it was.

RESOLVED, to request the Local Chief Executive Hon. Mayor. Alberto Jumalon Bongcawel thru the honorable body of the Sangguniang Bayan of Siayan, Zamboanga del Norte for the provision of the Annual Appropriation of Funds in the amount of **ONE HUNDRED EIGHTY THOUSAND PESOS (₱ 180,000.00)** for the honorariums of the Officers and Board of Directors of Municipal Federation of Senior Citizens Association of the Philippines (MFSCAP) Siayan Chapter to support them on their monthly barangay visitation activities of monitoring for the purpose of enabling and capacitating the officers of the twenty-two (22) Barangay Senior Citizens Associations of the Philippines (BSCAP) of Siayan, Zamboanga del Norte, **chargeable against the ONE PERCENT (1%) SHARE** from the Internal Revenue Allotment (IRA) of which it is now known as the National Tax Allotment (NTA) and Local sources or annual budget of the LGU for CY- 2025.


