CALIAO, PROVINCIAL DIRECTOR, PPO, CAMP HAMAC, SICAYAB, DIPOLOG CITY FOR THE ESTABLISHMENT OF CHECKPOINTS AT ALL ENTRY POINTS OF TERRITORIAL BOUNDARIES OF SIAYAN, ZAMBOANGA DEL NORTE.**

**WHEREAS**, the municipality of Siayan, by reason of its geographical location being isolated from the center of the province, has since then and now an infested area for lawless elements, operating and perpetrating criminal activities within the local government and its neighboring places, such as, but not limited to communist insurgency and rebellion,
