SIAYAN, ZAMBOANGA DEL NORTE."**

WHEREAS, the municipality of Siayan, by reason of its geographical location being isolated from the center of the province, has since then and now an infested area for lawless elements, operating and perpetrating criminal activities within the local government territory and its neighboring places. More prevalent is the sighting of armed communist guerilla and their organized peasant collaborators, doing mass-based organization and mobilization;

WHEREAS, the election period for the May 2022 national and local elections had commenced, and probably these lawless elements might conduct harassment and violations in favor of their candidate aspirants, wherein the municipality of Siayan had experienced political killings;
