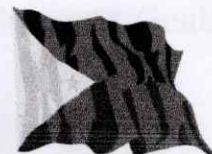

**RESOLUTION REQUESTING THE HONORABLE CONGRESSWOMAN GLONA GARCIA LABADLABAD REPRESENTATIVE OF THE SECOND CONGRESSIONAL DISTRICT OF ZAMBOANGA DEL NORTE TO ALLOCATE FUNDS FOR THE CONCRETING OF THE THIRTEEN (13) KILOMETER DOMOGOK-BASAK FARM-TO-MARKET ROAD IN BARANGAY DOMOGOK, SIAYAN, ZAMBOANGA DEL NORTE.**

**WHEREAS**, the farm-to-market road from Domogok Proper to its sitio Basak has a road length of approximately thirteen (13) kilometers with some critical uphill or difficult portions that also needs downgrading and widening to make it safer and passable during rainy days, and promote higher agricultural production and marketing of harvested agricultural crops such rice and corn, vegetables and root crops; and encourage local farmers to engage in farming permanent crops like rubber and coconut trees and exotic tropical fruit trees;

**WHEREAS**, the new set of newly elected Sangguniang Barangay Officials have agreed in session assembled to seek for external sources of funds to realize the priority project that is deemed as another key towards promoting and developing a stronger socio-economic activities leading towards an enhanced sustainable livelihood, income and progress of the barangay residents, thus contribute in attaining the common goals



and objectives under the United Nations Program on Millennium Development Goals (MDG) of which the Philippines is one of the signatories;


