A RESOLUTION REQUESTING FINANCIAL ASSISTANCE AMOUNTING OF FOUR HUNDRED TWENTY NINE TUHOUSAND ONE HUNDRED FOURTY PESOS TO HON. ALBERTO J. BONGCAWEL MUNICIPAL MAYOR, SIAYAN, ZAMBOANGA DEL NORTE FOR THE REHAB/ MAINTENANCE OF FARM TO MARKET ROAD OF BARANGAY PROPER - SITIO TALOGONG-SITIO MAMONGOL AND LITALIP OF BARANGAY DUMPILAS, SIAYAN, ZAMBOANGA, DEL NORTE.

WHEREAS, the Barangay Dumpilas had only three hundred twenty thousand pesos and need financial assistance to municipal represented municipal mayor Alberto J. Bongcawel of four hundred twenty nine thousand one hundred fourty pesos for the rehab/ maintenance of farm to market road of Proper-sitio Talogong-sitio Mamongol and sitio Litalip, Dumpilas, Siayan, Zamboanga del Norte.

WHEREAS, the said project need of amount of seven hundred fourty thousand one hundred fourty pesos for the rehab/ of farm to market road of three sitio's.

WHEREAS, road maintenance is work that takes place on roads from motorways to ensure they remain strong safe and efficient, aimed to keep road users safe and passable at all times; WHEREAS, the constituents of the sitio Talogong / Mamongol and Litalip are in need road rehabilitation and benefited consisting of one hundred household beneficiary as identified.
