RESOLUTION AUTHORIZING THE LOCAL GOVERNMENT UNIT (LGU) OF SIAYAN, ZAMBOANGA DEL NORTE REPRESENTED BY THE HON. MUNICIPAL MAYOR JOSECOR S. GEPOLONGCA TO DONATE A PORTION OF LAND OWNED BY THE LOCAL GOVERNMENT UNIT MEASURING FIVE HUNDRED SQUARE METERS (500 SQ. M.) IN FAVOR OF THE BUREAU OF FIRE PROTECTION (BFP) FOR THE SITE OF BFP STATION IN THIS MUNICIPALITY.

WHEREAS, the Bureau of Fire (BFP) is an agency of the DILG which was formed from the unit of the Integrated National Police's Office of Fire Protection Service on January 29, 1991 through Republic Act No. 6975:

WHEREAS, the BFP is responsible for implementing national policies related to firefighting and fire prevention as well as implementation of the Philippine Fire Code (RA 9514) and likewise shall establish at least one (1) fire station with adequate personnel, firefighting facilities and equipment in every provincial capital, city and municipality subject to standard rules and regulations as maybe promulgated by;

WHEREAS, the BFP fire station in this municipality is a recipient of One (1) unit fire station building wherein implementation of such required a certain lot/area to where the building be constructed;

WHEREFORE, premised of the foregoing consideration, and on motion of Hon. Oliver A. Romero, duly seconded by Hon. Estrella S. Zapatos, and Hon. Ma. Roselyn G. Secretario, it was

RESOLVED, as this body hereby resolved by AUTHORIZING THE LOCAL GOVERNMENT UNIT (LGU) OF \$IAYAN, ZAMBOANGA DEL NORTE REPRESENTED BY THE HON. MUNICIPAL MAYOR JOSECOR \$. GEPOLONGCA TO DONATE A PORTION OF LAND OWNED BY THE LOCAL GOVERNMENT UNIT MEASURING FIVE HUNDRED \$QUARE METER\$ (500 \$Q. M.) IN FAVOR OF THE BUREAU OF FIRE PROTECTION (BFP) FOR THE \$ITE OF BFP \$TATION IN THIS MUNICIPALITY.

RESOLVED FURTHER, that a parcel of land herein donated containing an aggregate area of FIVE HUNDRED (500) SQUARE METERS portion of Lot No. <u>20</u> within the municipal government lot situated at Bagsdakan area, Poblacion, Siayan, Zamboanga del Norte, bearing a copy of Transfer Certificate of Title No. T-71718, bounded as follows:

On the North by national highway measuring 20 meters; On the south by remaining portion of lot No. 20 - PCS-09-0037611, measuring 20 meters; On the East by remaining portion of lot No. 20- PCS-

09-0037611, measuring 25 meters; and on the West by Road Lot (Portion of Lot No. 233, measuring 25 meters; a total of 500 square meters;

RESOLVED FINALLY, to forward copies of this resolution to the Hon. Municipal Mayor Josecor S. Gepolongca and furnish to all offices concerned for information, reference and appropriate action.
