ORDINANCE NO. 01

Series of 2024

AN ORDINANCE ADOPTING THE OFFICIAL SEAL OF THE SANGGUNIANG BARANGAY OF DOMOGOK, SIAYAN ZAMBOANGA DEL NORTE, REGULATING ITS USE AND PROVIDING PENALTY FOE VIOLATIONS THEREOF,

Chairman, Committee on Laws & Ordinance

SECONDED BY: ALL Members Present.

WHEREAS, Sec 39 of R. A 7160, otherwise known as the Local Government Code of 1991, mandates that the Sangguniang Barangay shall be composed of the Barangay Captain as the Presiding officer. And the regular Sangguniang Barangay Members, the President of the Pambayang Pederasyon ng mga Sangguniang Kabataan and the Sectoral Representative, as member;

WHEREAS, the Sangguniang Barangay has envolved and emerged to be a dynamic body that focuses not just in local legislation but also in the meaningful exercise of Local Authonomy and effective and efficient delivery of basic service;

WHEREAS, adopting an official seal for the Office of the Sangguniang Barangay service the purpose of a concrete symbol of its authority as well as constant reminder of the duties and responsibilities of its officials and employees as defined under the Barangay Code, other laws and regulations effecting Barangay and Public Service;

THE OFFICIAL SEAL OF THE SANGGUNIANG BARANGAY OF DOMOGOK SHALL SHOW THE CHOSEN AND PRIORITIZED IMAGES INSIDE THE CIRCLE:

THE CARABAO

The Carabao represent as the main draft animal of the farmers of Barangay Domogok. It is the farmers' only means of ensuring a bigger cultivation during land preparation for the production of rice and corn, and other secondary crops or intercrops.

RICE AND CORN

The pictures of rice and corn symbolize the primary crops currently produced by the farmers of Barangay Domogok being the common staple food in the barangay main source of family or household income:

TAPPED RUBBER TREES SHOWING COLLECTION CUPS FILLED WITH LATEX OF NATURAL RUBBER.

The tapped rubber trees signify the vision and keen interest of the Local Government Unit of Barangay Domogok to find ways and means in providing financial assistance and planting materials of highlielding rubber clones of natural rubber trees, fertilizers and related tecnologies, infrastructure support towards high production and sustinable family or household income of its local farmers;

COCONUT TREES

The coconut trees also indicate the BLGU's desire to promote and help the local farmers in engaging coconut farming or encourage those who are already enjoying the economic benefits of their small scale coconut farms by making expansions or adding more plantings of the recommended coconut trees;

A. REGULATORY CLAUSE;

1. USE OF THE SANGGUNIANG BARANGAY SEAL

Only the office of the Sangguniang Barangay and its Local Officials and Employees shall use the corporate seal:

- As legal bases or reference in authenticating all barangay documents and other administrative issuances;
- To be affixed in the letterhead for official communications or correspondence in the exercise of the Sangguniang Baranggay legislative functions;
- c. To be affixed on such other official documents, plates and paper of the office of the Sangguniang Barangay of Domogok as may be provided by a Barangay Resolution or Ordinance, or as may be required by a custom or usage;
- d. To be affixed on Barangay Pins, services, rings, stickers, or be embroidered and affixed upon the uniforms of Barangay Officials and Employees.

2. CUSTODY OF THE ORIGINAL LAY-OUT OF THE SEAL.

The Office of the Sangguniang Barangay shall have custody of the original lay-out or draft of the Official Seal of the Sangguniang Barangay of Domogok, scanned and saved in a computer or in a dise.

3. PROHIBITED ACTS

It shall be prohibited;

- To mutilate, deface, defile, trample on, or cast contempt by any act or omission casting dishonor or ridicule upon the official seal
- b. To display the seal under any frame or picture;
- To display the seal in a platform or stage during programs not hosted by the Barangay of Domogok;
- d. To add any word, figure, mark,picture, design, drawings, advertisements, or imprint of any nature on the seal;
- To print, paint or attach representation of the seal on handkerchief, napkins, cushions, and other articles of merchandise except upon authority of the Sangguniang Barangay;

4. PERNAMENT DISPLAY OF CARVED CORPORATE SEAL.

As a sign of authority, there shall be made two (2) carved official seal of the Sangguniang Barangay of Domogok, either wood in wood, stone, brass, clay or other medium. They shall be permanenty attached/displayed at the office of the Barangay Captain and the Barangay Session Hall. These shall be in bigger sizes proportionate with the wall or room, and placed in an elevated, centermost dominant position.

A. PENAL CLAUSE;

- 1. Any person who commits the prohibited acts shall be meted a fine of One Thousand Pesos only. (Php. 1,000.00) or imprisonment of fifteen (15) days, or both such fine and imprisonment at the discretion of the court; provided that for any second and succeding offenses, both fine and imprisonment shall be imposed;
- 2. Any person who violates any provision of this ordinance, other than the prohibited acts shall be meted a fine of Five Hundred Pesos Only, (Ph 500.00) or an imprisonment for three (3) days, or both such fine and imprisonment at the discretion of the court; provided that for any second and succeeding offenses, both fine imprisonment shall be imposed.

SECTION 1. THE DRY SEAL OF THE OFFICE OF THE SANGGUNIANG BARANGAY OF DOMOGOK.

A. REGULATORY CLAUSE;

There shall be adopted in the office of the Sangguniang Barangay of Domogok a dry seal in authenticating Barangay documents or administrative issuances, a dry seal containing the official seal of the Sangguniang Barangay of Domogok.

B. PENAL CLAUSE;

- Any Barangay Officer or Employee who violates any provision of this ordinance shall be subject to reprimand, discipline, suspension or any administrative liability depending on the gravity of the offense, without prejudice to the filing of appropriate civil or criminal action;
- 2. Any person affixing the dry seal on any document without the know-ledge and consent of the Barangay Captain or the Barangay Secretary, or destroying the dry seal shall be meted a fine of Five Hundred Pesos Only, (Php. 500.00) or imprisonment or Barangay service of eight (8) hours or both fine and imprisonment or barangay service at the discretion of the court; without prejudice to the filing of appropriate civil or criminal action. Provided however, that person who destroy the seal aside from the penalty shall immediately replace the destroyed dry seal.

SECTION 2. SEPARABILITY CLAUSE;

In the event that any part or portion of this ordinance is declared to be illegal, unconstitutional or invalid, those parts or portion thereof which are not affected thereby shall continue to be effective and enforceable.

SECTION 3. REPEALING CLAUSE;

Any prior ordinance in conflict or inconsistent with this ordinance shall be deemed repealed or amended accordingly; this ordinace shall be incorporated in the General Ordinance of Barangay Domogok.

SECTION 4. EFFECTIVITY CLAUSE;

This ordinance shall take effect after complying with the requirement and posted and published as provided for under Section 59 of RA 7160.
