RESOLUTION INQUIRING THE DISTRICT ENGINEER, DPWH, OF THE 2<sup>ND</sup> ENGINEERING DISTRICT IN THE PROVINCE OF ZAMBOANGA DEL NORTE IF THE SANNGGUNIANG BAYAN HAS THE AUTHORITY BY ALLOWING FOR THE ESTABLISHMENT OF SIGNAGE ALONG THE NATIONAL HIGHWAY IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE, LIKEWSIE REQUESTING FOR ESTABLISHMENT OF PEDESTRIAN LINE (PAINTING) ACROSS THE NATIONAL HIGHWAY INFRONT OF THE CAMACOP CHURCH.

**WHEREAS,** submitted before this august for review and appropriate action was Resolution No. O1 of CHURCH MINISTRY TEAM (CMT) of CAMACOP CHURCH subject of such is requesting the Hon. Municipal Mayor Atty. Josecor S. Gepolongca through this august body to pass an Ordinance allowing the CAMACOP CHURCH to establish signage along the national highway in front of its edifice located in Bagsakan, Poblacion, in this municipality;

WHEREAS, the signage to be established is form of billboard with a caution as follows: "SPEED LIMIT" "SLOW DOWN" and "NO BLOWING OF HORN CHURCH SERVICE IS GOING ON";

**WHEREAS,** the intent of the church authorities is a precautionary measure not to be disturbed while on church service every Sunday;

**WHEREAS,** on the other hand, establishment of pedestrian line by way of painting across the road in front of the said church might aware of the riders on their speed limit the same time to avoid incidents against the church goers;
