RESOLUTION TO DEMOLISH THE OLD AND DILAPIDATED WEAK AND UNSAFE
WOODEN BARANGAY PUBLIC MARKET BUILDING OF BARANGAY PANGE TO CLEAR
OR REMOVE OBSTRUCTION FOR THE CONSTRUCTION OF THE PRIORITY FARM-TO-
MARKET ROAD THAT WILL CONNECT AND GIVE ACCESS FOR FARMERS IN
MARKETING THEIR FARM PRODUCTS AND ENCOURAGE PRODUCTION OF RICE AND
CORN AND OTHER CROPS; AND LIKEWISE TO FACILITATE THE CONSTRUCTION OF A
SAFER CONCRETE PUBLIC MARKET ON A DESIGNATED NEW SITE.

WHEREAS, the barangay Pange is continuing its farm-to-market road project that will connect
the agricultural areas of the sitios of the barangay;

WHEREAS; the construction of the farm-to-market road as per survey has to pass thru where the
old and dilapidated barangay public market its located;

WHEREAS; the new set of barangay officials of Pange agreed to demolish the old and
dilapidated weak unsafe wooden public market building and construct a new one on a designated new
site which is deemed far better than its present location while at the same time open the way for the
continued construction of a farm-to-market road that will extend to the sitios of barangay Pange to
encourage increase farm cultivations for higher farm production of rice and corn for food supply as
well as encourage the farmers to engage in the production of their crops with high potentials to
promote higher family income.


NOW, THEREFORE, in consideration of the foregoing premises, on motion of honourable barangay Kagawad Dalmacio A. Lubac, duly seconded by honourable barangay Kagawad Manuel G. Ebol together with the rest of the barangay officials present, it was

RESOLVED, as this august body hereby resolved, to demolish the old and dilapidated Barangay Public Market Building to clear or remove obstruction for the continuation of the construction of the priority Farm-to-Market Road that will extend to the sitios of barangay pange to encouraged increase farm cultivations for higher farm production of rice and corn for food supply as well as encourage the farmers to engage in the production of other crops with high potentials to promote higher family income;


