ORDENANCE NO. 01 Series of 2024

AN ORDINANCE ADOPTING THE OFFICIAL SEAL OF THE SANGGUNIANG BARANGAY OF MANGILAY, SIAYAN ZAMBOANGA DEL NORTE, REGULATING ITS USE AND PROVIDING PENALTY FOR VIOLATION THEREOF.

SPONSORED BY: HON. GENEROSO GIBANGGIBANG Chairman, Committee on peace and order

SECONDED BY: All members present

WHEREAS, under section 391 of the Local Government Code of 1991 (R.A. 7160) to wit: The Sangguniang, Barangay the legislative body of the barangay, shall be compose of the barangay captain as the presiding officer, the regular Sangguniang Barangay Members the present of pambayang pederasyon ng mga Sangguniang Kabataan, and the sectoral Representative, as members.

WHEREAS, the Sangguniang Barangay has evolved and emereged to be a dynamic body that focuses not just in local legislation but also in the meaningful exercise of local autonomy and effective and efficient delivery of basic services:

WHEREAS, adopting an afficial seal for the office of the Sangguniang Barangay services the purpose of having a concrete symbol of its authority as well as constant reminder of the duties and responsibilities of its official and employees as defined under the Barangay Code, other laws, rules and regulations affecting Barangay and public services.

The Official Seal of the Sangguniang Barangay of Mangilay shows the image inside the circle.

THE CARABAO

The Carabao is the main draft animal of the farmers of Barangay Mangilay it is the farmers only means of insuring a bigger cultivation during land preparation for the production of rice and corn, and other Secondary crafts or intercrops.

THE PLOW, THE YOKE AND THE ROPE THAT CONNECTS THE PLOW

The plow that is pulled by the Carabao thru the yoke and the rope and other accessories attached to the plow helps in making the work in land preparation, particularly during the first plowing and second plowing more easier and lighter for the farmers to accomplish their job.

The farmer represent the entire residents of Barangay Mangilay of their daily task and effort of insuring high production and sustainable food supply for their families, and the populace in the community.

The picture of the Carabao plowing the Plow and administered or manage by the farmer symbolize the cooperation and unity of the people residing or living in the Barangay to attain strong socio-economic development together with the Barangay officials.

THE HAND THAT HOLD THE BALANCE OF WEIGHING SCALE

The hand holding the weighing scale to maintain a balance represent fairness, justice and imposition or implementation of laws and state policies without bias and maintain respect on the right of the people to avail service of the barangay government unit as provided by law and or the local Government Code of 1991.

FLAG

Symbolizes the Republic of the Philippines and the Barangay Government of Mangilay, Siayan, Zamboanga Del Norte

THE RICE AND CORN

The rice and corn represent the barangay Mangilay, Siayan Zamboanga del Norte as the number one and first official livelihood of the people each serve as the mostly needed in every individual and every families.

THE GAVEL

The Gavel IS extremely important and necessary in the exercise of the legislative power of the Barangay. Its symbolize the authority and the right to act officially in the capacity of achier or presiding officer. It is use for commanding attention or confirming an action to keep the season or making itself calm an orderly in the closing or adjournment or proceeding, meeting or session the given reminds every member of the barangay of their duties and responsibilities as legislators.

A. REGULATORY CLAUSE

1. USE OF THE SAGGUNIANG BARANGAY SEAL

Only the office of the Sagguniang Barangay and its local officials and employees shall use the corporate seal:

a. To authenticate all Barangay documents and other administrative issuances.

b. As letterhead in official communication or correspondence in the exercise of the Sangguniang Barangay legislative and other functions.

c. To be affixed upon such other official documents, plates and papers of the office of the Sangguniang Barangay of Mangilay as maybe provided by a Baranagy resolution or ordinance, or as maybe required by costumes to usage:

d. As a symbol of the Barangay in all its affairs, within or outside of its territorial jurisdiction.

To be affixed upon Barangay pins, service, rings, sticker or be embroided and affix upon the uniforms of Baranagy officials and employees.

2. CUSTODY OF THE ORIGINALLY LAY-OUT OF THE SEAL

The office of the Sangguniang Barangay shall have custody of the original lay-out or drop of the official seal of the sangguniang barangay of Mangilay. Scanned and saved in the computer or in disc.

3. PROHIBITED ACTS

It shall be prohibited:

- a. To mutilate, deface, defile, trample on, or cast contempt by any act or omission casting dishonor or ridicule upon the official seal;
- b. To display the seal under any frame or picture;
- c. To display the seal in platform or stage during programs not hosted by the barangay of Mangilay
- d. To add any word, figure, mark, picture, design, drawing, advertisements, or imprint of any nature on the seal.
- To print, paint or attached representation of the seal on handkerchief, napkins, cushions, and other articles of merchandise except upon authority of the sangguniang barangay.

4. PERMANENTLY DISPLAY OF CARVED CORPORATE SEAL

As a signed of authority, there shall be need two (2) carved official seals of sangguniang barangay of Mangilay either in wood, stone, brass, clay, or other medium. They shall be permanently attached/display at the office of the Baranagy Captain and the Barangay Session Hall. These shall be in bigger sizes proportionate with the wall or room, and placed in an elevated, centermost dominant position.

A. PENAL CLAUSE

- 1. Any person who commits the prohibited acts letters (a) to (e) shall be meted a fine of One thousand pesos (1,000.00) or imprisonment of fifteen (15) days, or both such fine and imprisonment up discretion of the court; provided that for any second and succeeding offenses, both fine and imprisonment shall be imposed;
- 2. Any person who violates any provision of this ordinance, other than the prohibited acts shall be meted a fine of Five hundred (500.00) or imprisonment of three (3) days, or both such fine and imprisonment at the discretion of the court, provided that for any second and succeeding offenses, both fine and imprisonment shall be imposed.

SECTION 1: THE DRY SEAL OF THE OFFICE OF THE SANGGUNIANG BARANGAY OF MANGILAY

There shall be adopted in the office of the sangguniang barangay of Mangilay a dry seal in authenticating Barangay documents or administrative issuances, a dry seal containing the official seal of the Sangguniang Barangay of Mangilay.

B. PENAL CLAUSE

- 1. Any Barangay officer or employee who violates any provision of this ordinance shall be subject to reprimand, discipline, suspension, or any administrative liability depending on the gravity of the offense without prejudice to the filling of appropriate civil or criminal action;
- 2. Any person affixing the dry seal on any documents without the knowledge and consent of the Barangay Captain or the Barangay Secretary, or destroying the dry seal shall be meted a fine of Five Hundred (500.00) pesos or imprisonment or Barangay Service of Eight (8) Hours or both fine and imprisonment or Barangay service at the discretion of the court; without prejudice to the filling of the appropriate civil or criminal action. Provided whoever, that persons who destroy the dry seal aside from the penalty shall immediately replace the destroyed dry seal.

SECTION 2: SEPARABILITY CLAUSE

In the event any part or portion of this ordinance is declared to be illegal unconstitutional or invalid, Those part or portions thereof which are not affected thereby shall be continue to be affected and enforceable.

SECTION 3: REPEALING CLAUSE

Any prior ordinance in conflict or inconsistent with this ordinance shall be deemed repealed or emended according, this ordinance shall be incorporate to the code of General ordinances of Mangilay.

SECTION 4: EFFECTIVITY CLAUSE

This ordinance shall take effect after complying with the requirements as to posting in publication as provided for under Section 59 of R.A. 7160.
