**RESOLUTION REQUESTING THE HONORABLE MUNICIPAL MAYOR ALBERTO “ALI” J. BONGCAWEL FOR SOME ROLLS OF POLYETHELENE HOSE AND SOME LENGTHS OF BLUE PVC WATER PIPES FOR THE INSTALLATION OF WATER PIPES AND CONNECT HOUSEHOLDS FOR THE SUPPLY OF POTABLE WATER FROM SOURCE.**

**WHEREAS**, the supply of potable water for every household is an obligation by every local government unit to its people either in the rural or urban barangays;

**WHEREAS**, the new set of local barangay officials of Domogok have understood its role in promoting good health and nutrition to its subjects in the barangay;

**WHEREAS**, to connect households to the distribution line of the water system it needs some rolls of polyethylene water hose and blue PVC water pipes;

**WHEREAS**, due to limited funds, securing or purchasing those piping materials for the beneficiaries is beyond the capacity of the barangay to do;

**NOW, THEREFORE**, premise considered, on motion of Hon. Mariano R. Ganduyo, Chairman on the Committee on Indigenous People Affairs, duly seconded by Hon. Moel O. Ticol and the rest of the Sangguniang Barangay Officials present, it was

**RESOLVED**, to request from the Local Government Unit of Siayan thru the Honorable Municipal Mayor Alberto "Ali" J. Bongcawel several rolls of polyethylene water hose and several lengths of blue PVC water pipes for the installation and connections of drinking water from the distribution lines to the households to promote and ensure sanitation, observation of personal hygiene and health and nutrition;


**RESOLVED FINALLY**, to furnish copies of this resolution to the Sangguniang Bayan of Siayan and to the Hon. Alberto "Ali" J. Bongcawel, Municipal Mayor of Siayan for their information and appropriate action.
