WHEREAS, for the year 2024 the Department of Health (DOH) shall implement nationwide the second phase of bivalent Oral Polio Vaccine (bOPVSIA) to vaccinate children in the remaining municipalities and barangays.

WHEREAS, the direct benefits of childhood vaccination in reducing the burden of disease morbidity and mortality in a cost-effective manner are well-established.
